4 Chair's Report

4.1 On line Entry

5.4 Year Book Production

- Ken has been moving mountains again to get the Yearbook to printer's draft. Again the meeting expressed its thanks for all his efforts.
- We need to firm up on a day to 'do' the packing. Making sure that this time we include event organisers and advertisers in the circulation.
- CDW proposed that some time is spent at the next meeting reviewing the purpose of the yearbook, and looking at the sections in the yearbook, to review whether they should be included or not. The yearbook is getting thicker all the time, and has increasing duplication in it, making maintenance harder. Individuals on the committee should seek feedback from slalom stakeholders.
- We need to find a compiler for 2018 to replace Ken.

5.5 British Open 2018

The British Open 2017 will be a ranking points event

It was agreed that the 2018 event will be requested as a ranking points race. CDW is instructed to apply before the ICF deadline of 1st March 2017.

5.6 Entry Cards

New Entry Cards have been produced, three to a page, perforated. It was agreed that the current stocks of blue cards should continue to be used before the new cards are issued. New versions will be included with yearbook 3 each. Organisers should accept both card formats. No cards from the event shall be posted anywhere by organisers post-event.

5.7 ACM 2017 Motions

1. Race Formats – do we want to change the race formats (again) to include Czech model?
2. Statutes – action is on CDW, waiting for information from Vasi as to BC ambition to make statutes similar across disciplines.
3. Early Course erection – should we be considering limits on when courses can be erected, to reduce the magnification of home advantage in that the water is known and so is the detailed course.

6 Finance

6.1 Budgets

Co-ordinators were encouraged to produce budgets for the 2016-17 year and supply them to AK before the next meeting. Provisional budgets have been developed based on last years' expenditure. The current year income is expected to be in-line with 2016. If nothing unforeseen happens we are heading once again for a surplus.

14.2 Scotland

14.2.1 *SCA Slalom Committee*

No one is prepared to be Chair of SCA slalom committee. It has been requested that all communication is sent to the secretary who will distribute. Committee members will take turns to chair the meetings.

14.2.2 *Grandtully*

It is looking hopeful that The Adventure Show will be coming to film at the Grandtully Premier event but no confirmation yet.

Hopefully all Grandtully stanchions and all the bearers will be in place for the Premier in early April following the construction work on the far bank last year.

The Scottish Champs is returning to Grandtully this year and a ceilidh will be held in the evening.

14.2.3 *Selection 2018*

It is very disappointing to see that the proposal is for selection 2018 to be on Easter weekend next year.

For Scots paddlers, the timing of the Grandtully races, whether in school holiday or not is not a big issue as all paddlers can get to Grandtully at a reasonable time leaving after work on a Friday.



This year I have received many e mails and calls from paddlers and coaches south of the border who traditionally use the week before the div 1 race at Easter to hold a training camp to say they were disappointed with the date we had chosen for the Easter div 1 race as it does not include their Easter holiday. This is not possible when the race does not coincide with the Easter holidays. The problem was that our choice of dates is limited by selection using Easter.

Easter 2018 is early March 31st/April 1st.

Trying to put in the Premier and Div 1 races at Grandtully if selection is easter next year would mean the prem being mid-March which is encroaching on the traditional Shepperton dates or later which is likely to mean fewer participants willing to travel.

Personally, I do not think tradition is the be all and end all but when we were asked to move Grandtully div 1 to accommodate selection a few years ago we were assured that this would not be permanent and it was because of getting boats and people out to Oz.

However, in this case the development opportunities for many are being sacrificed to accommodate a selection weekend which could easily be held on the early bank holiday May weekend. The first International race the selection results are needed for is in June in Europe so having a clear month should not pose a problem.

14.3 Northern Ireland

14.3.1 Performance Documents

CANI have invested significant time and resources into the updating and creation of all documents relating to the Performance Pathway. These are all online now on the CANI Website and will be introduced in 2017.

14.3.2 Talent ID

CANI carried out Stage 1 of testing on approximately 100+ 10-11 years old in several Primary Schools in the Greater Belfast Area. We hope to kick off a Talent Academy programme in April 2017

14.4 Wales Report

Paddlesport within Wales is developing well with a considerable amount of effort still taking place with the development of Sprint and slalom within schools and clubs across Wales.

Winter training groups are being finalised with Premier and Division 1 groups. Division 2 and 3 paddlers will be invited to training camps on a quarterly basis funded by the Canoe Wales Slalom Committee.

Training sessions are taking place throughout the Winter at various locations around the UK – Bala, Llandysul, Nottingham, Cardiff and Lee Valley.

At the recent committee meeting several issues were discussed including – Competition Prizes, Judging, Slalom Development, Volunteer encouragement, and Committee races.

The timing team are planning on timing the Division 1 and Premier races being held in Wales. Trials will be had at lower division races for the new timing system.
